### **2018 I-LYA Junior Program WAIVER and RELEASE**

The undersigned Parent/Guardian of the Sailor named above who has also signed below, desire and consent to have the Sailor participate in The Junior Program of the Inter-Lake Yachting Association (I-LYA), including The Junior Sail Regatta at Put-in-Bay, Ohio and The Traveler Series which is hosted by individual clubs who are members of I-LYA and also in such regattas, clinics and other social activities and events, both on and off the waters, which activities are related solely to the Junior Program (the "Events"), and therefore enter into this Waiver and Release for the benefit of I-LYA and the Host Clubs, which for this 2018 Schedule are listed on the I-LYA website (<http://www.I-LYA.org>). The parties hereto agree that changes to the 2018 Schedule, including times and venues, may be made at any time at I-LYA's sole discretion.

The undersigned agrees that the Sailor's home club or association, all Host Clubs, I-LYA, and all of their respective members, officers, directors, employees, agents, volunteers, as well as all persons acting in a volunteer capacity regarding the conduct of the Events ("Released Party" or collectively "the Released Parties"), shall not be responsible or liable for the personal injury, death, and/or property loss or damage suffered by the Sailor or any third party arising out of or related to the Sailor's participation in the Events whether or not any such liability is caused in whole or part by the negligence of a Released Party. By consenting to the participation of the Sailor in the Events, the undersigned, himself/herself and on behalf of the Sailor and their respective heirs, successors, and assigns, hereby waives all claims against the Released Parties for, and releases the Released Parties from, any and all liability, including personal injury, death and property damage claims arising out of the Sailor's participation in the Events, whether or not any such liability is caused in whole or part by the negligence of a Released Party, to the fullest extent permitted by law.

However, the undersigned Parent and Sailor do retain any and all rights against any other party for damages of any nature resulting from any intentional acts and/or wrongful acts not directly related to the Sailor's participation in the daily activities of the Events, including all times before the start and after the activities of the Events for that day. Parties hereto understand that in accordance with Rule 82 of the Racing Rules of Sailing and the Bylaws of US Sailing, no indemnity clauses shall be required by any party.

The undersigned gives permission for photographs and videos of the Sailor to be used at the sole discretion of I-LYA and that Host Club at which the photo was taken.
